A minimum of \$20 deposit (non-refundable & non-transferable)/week /child to hold your spot.

*Week 3: Closed Monday & Tuesday, July 3rd & 4th. 3 day fee option only.

**Final day of Summer Day Camp is 8/25/23 for South and Valley, 8/30/23 for Central and North - 3 day fee option only.

Day Camp Fees

3 Day Fee: \$162 Community Member / \$152 Y-Family Membership
5 Day Fee: \$270 Community Member / \$260 Y-Family Membership

Weekly Auto Withdrawal Options

Charged on payment deadline date.

Monthly Auto Withdrawal Options

Charged on 1st of each month or before program starts.

June 13th = Weeks 1-3
July 1st = Weeks 4-7
August 1st = Weeks 8-11

Separate from Reg form, completed Child Info forms will be required in advance to be fully registered and allowed to attend.

The forms will be emailed after child(ren) are registered. Email forms back to YMCA.SAC@ymcainw.org.

All Changes/Cancellations must be in writing by Monday of the week before the session begins (a week prior) and emailed to Childcare-Schoolageprograms@ymcainw.org.

DCYF Participants

All locations and programs licensed except South.

Copayments are due on the 1st of every month.

-DCYF participants can pay your copay with the registration or on the 1st of each month.
-Contact DCYF & provide them with the day camp provider # for the day camp location you want. 1-877-501-2233 (DCYF authorizations due by June 2nd to start the first day of camp.)

- **SUSPENSIONS** will be made by the **10th** of the month for late monthly payments.

-If DCYF doesn't cover care you will be responsible to cover the costs of care used.

IMPORTANT NOTICE – If your child misses more than two weeks of scheduled attendance without advanced written notice, they will be disenrolled from the program and will need re-registration IF space is available.
